2.1	For the right to place a memorial on a grave in the part of the cemetery reserved for interment of cremated remains.	£50	£100

2.3	For the right to place a second or subsequent inscription on an authorised memorial.	£30	£50
2.4	For the right to place a plaque on the Memorial Wall.	£40	£40
3.	GRANT OF BURIAL RIGHTS		
3.1	For grant of burial rights in a grave in that part of the cemetery reserved for interment of cremated remains.	£100	£300
3.2	For grant of burial rights in a grave in any other part of the Cemetery.	£200	£550
4.	TRANSFER OF BURIAL RIGHTS		
4.1	Form of Assignment Used by a living owner to transfer or change the ownership.	£25	
4.2	Form of Assent Used to transfer the ownership from an Executor or Administrator after the ownership has been transferred into their name by production of Probate or Letters of Administration.	£25	
4.3	Form of Renunciation May be used with a Statutory Declaration when a grave is being claimed by more than one person i.e. the deceased may have three children as next of kin, and one or more of those children wishes to give up their Rights to the ownership.	£25	
4.4	Statutory Declaration Used to transfer ownership from a deceased owner when no official documents have been issued. Declarations can either be based on a Will that did not go to probate, claiming ownership by the executor or by the Next of Kin if the deceased left no Will.	£40

6.	OTHER MATTERS				
6.1	The fees set out above apply where the person to be interred or in respect of whom the right is granted is, or immediately before his/her death was, an inhabitant or parishioner of the Parish of Medstead or, in the case of a still born child, where the parents (or one of them) are, or in the time of interment were, such inhabitants or parishioners.  The term "parishioner" shall include:  a) Anyone who ceased to be an inhabitant of the Parish less than one year before the date of his/her death;  b) Anyone whose name appears on the Register of Electors of the Parish in force at the time of his/her death;				
	c) A child under 18 years of age, one of whose parents qualifies as a parishioner at the time of the child's death;				
	d) A resident of an Old Peoples' Home or equivalent definition who, immediately before entering the Home, was an inhabitant of the Parish.				
6.2	The above fees include expenses incidental to preparation of necessary documents.				
6.3	These charges are effective from 1st February 2019, and may be altered from time to time as the Council decides.
