4. NEIGHBOURHOOD POLICING TEAM UPDATE

## 5. HAMPSHIRE COUINTY COUNCIL REPORT

Cllr Kemp-Gee reported the following issues:
$>$ A 5\% increase in Council Tax.
$>$ He has been 18 years a County Councillor, where the balance of expenditure has changed dramatically, now almost all from Council Tax, whilst total amount at $£ 1.1$ billion is much the same granted central government.
$>$ Significant cuts in RSG and council tax freezes hence dramatic cuts in other services.
$>$ HIGHWAYS and potholes case in point. AR Division $=100$ sq miles, $6 \%$ of Hants 5000 miles of roads. $£ 180$ million is Highways budget for all Hants.
$>$ Gov. Spring Budget $£ 6$ million sticking plaster will mean 40k extra pt holes repaired this summer.
> LOCAL MATTERS -

- School/VH bell mouth and pavement etc. Hope to commence the work in August 2023.
- Bridleways and BOATS round RDA Medstead
- Safety on local roads notably South Town Rd / Paice Lane bends area.

Mr Whapshare said that FP10 near Grove Farm had had a kissing gate supplied by Medstead Parish Council had been installed by the Alton Ramblers.

He further reported that there were access issues on the footpath near Foul Lane where a radar key was needed for disabled access. He was advised to report this on the HCC Report a Problem web page.

The Parish Clerk reported on the current position with the Mulcock Charity. Two new potential Trustees have come forward and Mr O'Farrell will liaise with both in taking forward their Trusteeship.
